Women's control over land and state open water-bodies:

A total of 540 women land owners and fisher folk are educated on land documentation, water-bodies allocation and record keeping, while 43 women land owners are supported with land boundary map, ownership deed, record/succession certificate/mutation collection.

CASE STUDY OF MARUFA

Marufa's in-laws inheritance lands were seized by other influential people. She did not have any information about the land ownership documentation and how to assert her rights. After Badabon Sangho made women aware of land rights, Marufa came to know about her rights. Badabon Sangho helped her collect land ownership documents from local land offices including succession certificate and then assert her rights of record. Now she got the possession of her land back.


