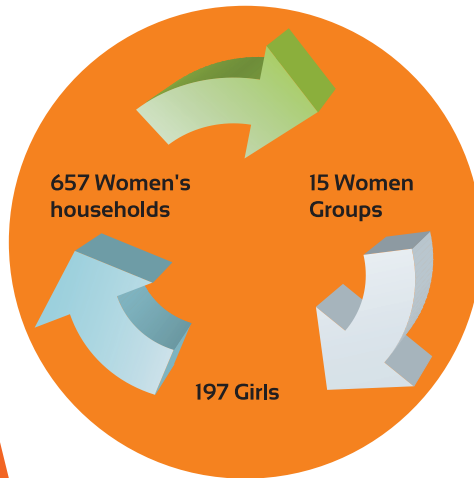
Target Population

Single mother, divorced, widow, separated, disable, sex worker, elderly, minority, indigenous, and displaced women and girls.



Women's Organisation (WG) development

Day by day widow, separated and single women and mother with or without children are increasing, becoming vulnerable for human trafficking, harassed, early/forced marriage and living under poverty line.



We facilitate **15 women and girls groups** (each group has 30-35 members), conduct courtyard meetings on weekly basis, provide trainings and implement community actions. We talk on the issues i.e. girl's reproductive health, women rights, disaster preparedness, resilience livelihoods and violence against women with technical support of Girls not Bribes, CEI - ITALIAN BISHOPS' CONFERENCE and We Can Alliance.

Combat violence against women (VAW)

Since inception, we facilitate awareness campaign in **13 villages with 11,826 populations** on types, nature and definition of violence against women and girls through folk songs, courtyard meetings and mass gathering. Always we stand on side of victimized

women and girls with united voice and helping to fight against violence. During the year, we supported **15 women and girls** to get access to justice through local Union Parishad, Police Station, Upazila Health Complex and District Legal Aid Committee.



Women's control over land and property

Privatisation and industrialisation are rapidly growing surrounding the second largest sea port in Mongla in Bagerhat. Women and girls are the vulnerable within the situation as they do not have awareness, ownership documents, voice and organisations.

We supported **26 women landowners** through counseling and reference in land registration, land mutation and successor certificate. Team received training on Geo-ODK (with assistance of Cadasta Foundation) and supporting women in ownership documentation.

Women and Girls in disaster preparedness

Humanitarian crisis and natural disaster becoming reality in coastal areas in recent times i.e. cyclone Sidr 2007, cyclone Aila 2010 and Mora 2017 along with heavy rainfall, monsoon flood, water logging and saline intrusion have already resulted in damage in livelihoods options, homes and forcing people to migrate out of region. We facilitate **five (5) youth clubs with 142 volunteers**, provide awareness, know-how, information of humanitarian standards with assistance of Need Assessment of Talent Development Project (entry level trainee scheme), Save the Children-UK. Badabon provides scholarship support to six (6) extreme poor girls for continuing education.



Women's voice in drinking water sources management

Due to the saline intrusion, shrimp farming and water logging, communities are suffering in scarcity of drinking water. In family, mostly women and girls are responsible for water collection from pond, pond sand filter and deep tube well. However, women do not have voice in the process of drinking water source maintenance. We facilitate **three (3) drinking water sources management committee for 2,053 households** through meetings and knowledge sharing.

Women's climate resilience livelihoods

We believe in women empowerment through involving them in resilience livelihoods activities, decision making and moving within public places. We link **657 households** with income generation and educate communities of mother, adolescence girls and children's health and nutrition.

Sex workers and children's rights

During the reporting year, we did the Need assessment of Mongla brothel (called Baniashanta brothel) in order to support workers and children. It is notable, the brothel is really vulnerable during cyclone due to location, salinity and don't have movement transport. However, customers are increasing due to industrialisation surrounding the sea port.

Women in Natural Resources Management (NRM)

We educating Sundarban surrounding populations on eco-friendly tourism, preservation of bio-diversity, protection of animals and forests through using contextual and traditional tools and techniques. A total **17,500 population** of five villages are educated on NRM by Women Groups.

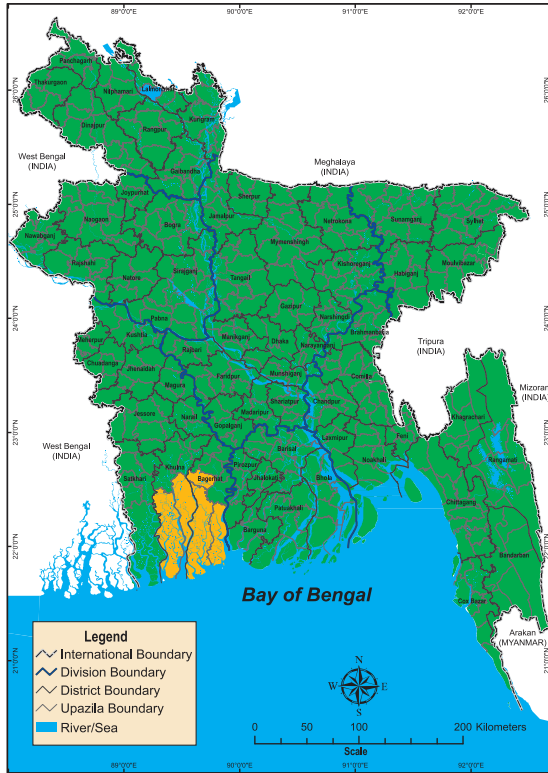

Toma Roy (17), daughter of Panchanon Roy, village: Burerdanga, upazila: Mongla passed Higher Secondary School in 2017 and victimized of forced marriage with a double aged man living in Khulna district. From the first day at in-laws house, she has been victimized of physical torture for additional dowry, even her parents already paid the conditional dowry at the time of wedding ceremony. She was not allowed to sleep in room, she slept at open space of house alone. She described the situation to her parent, her mother is member of Badabon Women Groups. Women Group has facilitated a meeting with local Union Parishad's Chairman and asked to conduct arbitration according to the Family Laws. Women Group communicated with other Chairman where Toma's in-laws are living and forced to sit Toma's husband in meeting. Toma's husband tried to keep away and not to sit in meeting with influence of powerful people. However, due to pressure of women groups and united community, chairman called a meeting on 22 Oct 2017 and instructed Toma's husband to return all dowry to Toma and forced to sign the divorce letter. Toma is now free and starting to study in Digraj Collage on Bachelor of Arts (BA). *'I got return of my dreams due to support of Badabon Sangho, many thanks to them.'* Badabon Sangho has did a facilitating role behind the fight with strategic connection and logistics.
